**NOTES AND INFORMATION FOR AUTHORS AND THEIR EMPLOYERS**

**Vertiv/Battcon Policy**

In connection with its publishing activities, it is the formal policy of Vertiv to own the copyrights to all copyrightable material in its technical publications, and to the individual contributions contained therein, in order to protect the interests of Vertiv and Battcon, its authors and their employers and, at the same time, to facilitate the appropriate reuse of this material by others. Vertiv/Battcon may distribute its technical publications throughout the world and does so by various means such as hard copy, microfiche, microfilm, and other electronic media. It also abstracts and may translate its publications, and articles contained therein, for inclusion in various compendiums and similar publications, etc. When an article is submitted for publication to Vertiv/Battcon, the conference and its sponsor understands that its acceptance of the article implies that Vertiv/Battcon has the rights to do all of the things it normally does with such an article.

The following policy applies to all materials presented to Vertiv for the purposes of the Battcon conference. Vertiv/Battcon must assume that all material presented at its meetings or submitted to its publications is properly available for general dissemination to the audiences these activities are organized to serve. It is the responsibility of the author(s), not the conference or its sponsor, to determine whether disclosure of their material requires the prior consent of other parties and, if so, to obtain it.

Furthermore, Vertiv/Battcon must assume that, if an author uses within his/her article previously published and/or copyrighted material, that permission has been obtained for such use and that any required credit lines, copyright notices, etc., are noted.



### **Vertiv/Battcon Obligations**

In exercising its rights under copyright, Vertiv/Battcon will make reasonable efforts to act in the interests of the authors and employers as well as in its own interest. In handling third party reprint/republication requests for Vertiv/Battcon "Work", Vertiv/Battcon requires that:

1. The consent of the first-named author be sought as a condition in granting republication (of a full paper) to others.
2. The consent of the employer be obtained as a condition in granting permission to others to reuse all or portions of a paper for promotion or marketing purposes.

### **AUTHOR/EMPLOYER RIGHTS**

If you are employed and you prepared your paper as part of your job, the rights of your paper initially rest with your employer. In that case, when you sign the copyright transfer form, we assume you are authorized to do so by your employer, and that your employer has consented to all the terms and conditions of this form. If not, it should be signed by someone so authorized.

### **Special Note to Employers**

Just as Vertiv/Battcon requires a signed copyright transfer form (for copyrightable material) in order to do "business as usual," it is the intent of the transfer portion of the form to return rights to the author and employer so that they, too, may do "business as usual."

Please note that, although authors are permitted to reuse all or portions of Vertiv/Battcon copyrighted material in other works, this does not include granting third party requests for reprinting, republishing or other types of reuse. All third-party requests must be handled directly by Vertiv/Battcon.

### **JOINT AUTHORSHIP**

For jointly authored papers, have ALL the joint authors sign, or at least have one of the authors sign as an authorized agent for the others. In the case of multiple authorship where one or more authors are government employees but at least one author is not, that non-government author should sign Part A of this Copyright Transfer Form.

### **U.S. GOVERNMENT EMPLOYEES / U.S. GOVERNMENT CONTRACT WORK**

Authors who are U.S. Government employees are not required to sign the Copyright Transfer Form, but any co-authors outside the government are required to sign. Authors whose work was performed under a U.S. Government contract or grant, but who are not government employees, are required to sign Part A of this Copyright Transfer Form.
